How will the Forum seek to promote or improve the neighbourhood area in terms of its social, economic and environmental well-being?	
Social well-being	<p>The long term objective of the Forum is to ensure sustainable development, that the quality of life for current and future residents is taken into account at each stage of development. We will also ensure that everybody in the area is involved at every stage of the process.</p> <p>The Neighbourhood Forum will help bring together different parts of the community who ordinarily do not get to meet, which will help to ensure community cohesion. By co-ordinating the delivery of new community spaces we also help bring the community together.</p>
Economic well-being	<p>By making the area a great place to live and work we further encourage the economic development of Canary Wharf, one of the most important business centers in the UK. Many residents (but not all) live in the area and work in Canary Wharf. However there has been a historical trend for families to move away from the area once they have children, that creates disruption for the local community and businesses. The high quality of the Canary Wharf estate needs to be matched by a complimentary high quality hinterland otherwise the quality and international reputation of Canary Wharf will be impacted if the area is seen as high quality offices surrounded by lesser quality residential and public infrastructure. We will also try encourage a broad range of jobs and activities in the area which is particularly important given that the area is becoming increasingly residential.</p>
Environmental well-bring	<p>The Forum will work to ensure that the environment of the area is not compromised and where possible it is enhanced by providing additional green spaces. We will seek to protect &amp; enhance the existing flora and fauna where they exist within the area.</p>
How will the Forum embed the Council’s guidance and aspirations within the Community Plan, Core Strategy, Managing Development Document and Diversity and Equalities Statement in their activities?	
Mayor’s Priorities and Community Plan	<p>We align ourselves with the Mayor’s Priorities in the following ways</p> <ol style="list-style-type: none"> <li>1. Housing - Delivery of additional social housing</li> <li>2. Young people – Delivery of additional schools, play areas and children’s facilities – ensuring that children can grow up active, well</li> </ol>

educated and healthy and are not kept inside all day. Young people are a key driver of the Forum as their needs have not kept pace with development in the area.

3. Jobs and economy – ensuring that a wide range of jobs are available and that we protect Canary Wharf’s global reputation as a centre for business
4. Cost of living – we will try to ensure through good design and environmental standards that properties are energy efficient, that there is a range of retail providers for different segments of the market and that there is good access to public transport.
5. Community safety – ensuring that we design in community safety through the use of better street lighting, pedestrian crossings, CCTV and engaging with residents of all ages as to their needs

We align ourselves with the Community Plan in the following ways;

1. A great place to live – is at the heart of what we are trying to achieve and will we try to make Tower Hamlets a place where people are proud to live, work and study.
2. A healthy and supportive community – by ensuring that residents can have active healthy lifestyles through good access to local facilities, green open space, safe play areas and access to walking and cycling routes.
3. A safe and cohesive community – by designing in better security to ensure a safe environment at all hours of the day. To try and design out ASBO behaviour by providing facilities for young people to enjoy themselves safely but not at the expense of other residents.
4. A prosperous community – by ensuring that residents have access to good local jobs, low cost housing and cheaper living.

#### Core Strategy & Managing Development Document

The Forum seeks to expand and build upon the foundations laid by the Core Strategy and Managing Development documents. We would propose to add a more granular level of detail below that already outlined. Both documents are relatively high level aspirational documents which we hope to build upon with supporting detail where necessary. Where new policies are being developed e.g. South Quay Masterplan & Opportunity Area Planning Framework, we will provide a local perspective in order to ensure that the Masterplan policy complements what we plan to do in our subsequent Neighbourhood Plan. We hope to use the South Quay Masterplan public consultation process to achieve the following aims;

1. Agree core principles that can be used in the wider area
2. To engage with the public during the public consultation on what they want from their built environment
3. As an education in the planning system and how to develop a plan

We are also guided by the London Plan and the National Planning Policy Framework.

Valuing diversity is one of our core values. We will promote diversity and equality in everything we do to improve the quality of life for everyone living, working and visiting the area. We will comply with the [The Equality Act 2010](#)

**How will the Forum envisage engaging with other local forums and groups including the Local Community Ward Forums ?**

Community ward forums are still in the process of being appointed for the new wards as this application is being prepared. As soon as they are formed we will engage with them as our consultations and advertising can also be used to help publicise their efforts. However we do have a former Community Ward Forum member for Blackwall & Cubitt Town and a newly appointed member for Canary Wharf ward in the Forum.

Members of the Forum already sit on or attend a wide variety of local organisations especially Councillors who between them attend meetings at places as diverse as Barkantine Surgery patient panel, Barkantine Management Team, Docklands Sailing centre, St Johns Leaseholders, Friends of Island Gardens, Association of Island Communities etc. The six councillors will between them attend or meet most of the local associations or group in the area. Separately we have also held meetings with Canary Wharf Group, Canal & Riverside Trust, East End Community Foundation & One Housing Group and talked to other local groups like the Scouts.

**How have the Forum taken steps to promote the opportunity for a Forum and engage with local people prior to submitting this application? This may include evidence of discussions, meetings and consultations.**

We have followed multiple strategies in order to publicise the Forum;

1. The delivery of over 12,000 letters to properties in the area from Councillors using Tower Hamlets Council headed paper inviting residents to attend public meetings and providing contact details. We believed that the use of Tower Hamlets headed paper would increase the likelihood of the letters being read.
2. The use of emails using existing contact details gathered in the months before the Forum was founded and then through word of mouth. We currently have 335 contact details on our distribution list but we know that our emails are being re-broadcast to a wider group especially within residents associations.
3. The use of social media to advertise the Forum;

The Forum currently includes 6 of the 7 elected Councillors for the three wards, representing Labour and Conservative Party members. The seventh Councillor is Vice-Chair of the Strategic Development Committee and therefore has not been approached directly as we believe there may be a conflict of interest between that role and being an active member of the Forum. However one of the candidates in the May 2014 elections for the Tower Hamlets First party is a member so we have representatives from the three parties represented on the Council.

We have over 340 contact details of people and organisations from across the area. They represent local people, local businesses, residents associations and other local organisations. On the membership form we have gathered peoples address, membership intentions, gender, age, disability status and ethnic composition to ensure the group is representative.

147 people or groups have filled in a membership form and live in the area  
16 people filled in a membership form but live outside of the area and will be associate members  
13 people filled in a membership form but just asked to be kept updated  
164 people have supplied their contact details but have not yet filled in a membership form or there form has not yet been processed. Many of those people have attended meetings and are interested in helping and we will chase them to fill in membership forms.

We have sent letters and emails to businesses in the area and this is something we are focused on pursuing during December.

We have also engaged with Canary Wharf Group given their importance to the area and we believe they will join as an Associate Member once we have been recognised.

**Why is the boundary of the Neighbourhood Planning Area considered to be appropriate?**

How does the boundary taken into account the physical, economic and social characteristics of the area?

The Forum Area has very clear hard physical boundaries – with either rivers or major A roads marking the boundaries except for a very small section between Westferry DLR station and the river Thames where the boundary adjoins the Limehouse NPF boundary.

On three sides we have water, with the river Thames and Bow Creek marking our boundaries and the northern side the boundary follows the the A1261 Aspen Way, A12/A102 and A13 A roads.

Canary Wharf Group has proposed that their estate be excluded from the area but it also has water surrounding most of the estate and security gates on its four road entrances which helps to clearly delineate the area. No residents currently live in the estate. The boundary also follows exactly the political ward boundaries of Canary Wharf, Blackwall & Cubitt Town and Island Gardens wards which makes communication and any eventual referendum much easier to organise. However we also have approximately 30 properties on Naval Row in the Poplar ward within the Area.



Transport is a key connecting issue with resident and businesses in the area all reliant on the same transport network. They currently all use the same Jubilee line station (& Crossrail in future) and two DLR lines which all end in Bank. They are also largely reliant on the same road network to exit the area with traffic buildup towards the Blackwall Tunnel/A12 clogging up the local road network.

The boundary also aligns closely with the Local Area Partnership 8, the Isle of Dogs Area Action Plan, and the London Plan housing target. We assume that the boundaries of the Opportunity Area Planning Framework follow a similar logical area as that is also development driven. The area also has generally similar economic characteristics – increasingly residential as a large number of offices are due to be replaced by residential buildings e.g. South Quay, Clove Crescent. However the area also includes some of the largest potential new office sites in London e.g. North Quay, Riverside South, Billingsgate. The area is being transformed by a huge number of new developments either already approved (ASDA), under construction (Indecon), just approved (South Quay Plaza), in the planning process (Meridian Gate), in consultation (Alpha Square) or rumoured (offices along South Quay by Hilton Hotel).

The social characteristics of the area are very similar based on the ward profiles (from the 2011 Census), see attached appendix;

- Age profile – the area has a higher proportion of working age population then the rest of Tower Hamlets at 79.8% (TH) and a lower % of children and older age groups.
- Ethnic mix – All other ethnic groups 22.6% is twice as high as TH as a whole at 11%. Other white at 19% is significantly higher then the TH average of 12%. White British, mixed and black ethnic groups have a similar % to other parts of TH but the Bangladeshi origin ethnic mix is 14.6% which is less then half of the TH total of 32%
- Housing tenure – private rented at 45.7% is significantly higher then the TH average of 32.6%. Social rented % is correspondingly lower at 23% versus 39.6% for TH as a whole. Owner occupiers % is similar.
- Labour market participation – in employment at 68.7% is 11.1% higher then TH average, all other categories are below the TH average
- Qualification – the % of residents with a Level 4 qualification is significantly higher at 57% then TH as a whole at 43.6%

All three wards are more similar to each other then the rest of Tower Hamlets.
